**Explanation of Responses:**

1. Represents restricted stock unit award that includes 2,200 shares which will vest in four equal annual installments, and 3,200 shares which will vest on a performance-based schedule tied to the Company's stock price and/or the achievement of certain financial metrics. This award includes a provision for the automatic withholding of shares to satisfy the withholding tax liability on each vesting date.
2. 12.5% of the option becomes exercisable on the date listed in the "Date Exercisable" column; the remaining 87.5% becomes exercisable in 42 equal monthly installments thereafter.
