This Registration Statement on Form S-8 (the "<u>Registration Statement</u>") is being filed for the purpose of registering an additional 1,400,000 shares of common stock, \$0.01 par value per share (the "<u>Common Stock</u>"), of Avid Technology, Inc. (the "<u>Company</u>"), which have been authorized and reserved for issuance under the Avid Technology, Inc. Amended and Restated 2014 Stock Incentive Plan. Accordingly, the contents of the Company's registration statements on Form S-8 filed with the SEC on May 30, 2018 (File No. 333-225279), June 12, 2017 (File No. 333-218677) and November 12, 2014 (File No. 333-200139) are incorporated by reference into this Registration Statement pursuant to General Instruction E of Form S-8.
